Case Law

- R v Singh (2012) The accused is sentenced to 8 year imprisonment for manslaughter, after successful plea of provocation by his wife, the victim.
- R v Loveridge (2013) The accused enters a guilty plea for manslaughter, and receives a minimum prison term of five years. Generates wide ranging law reform to combat "king hitting."
- Corey Davis Case: A 10 year old is found guilty of manslaughter after pushing a toddler into a river.
- R v AEM et al (2002): A group of men is charged with a new criminal offence "aggravated sexual assault in company."
- R v Franklin (2009): Charges of sexual assault and kidnapping are mitigated based on psychological factors and intoxication.

Responses

- Victim Impact Statement: Statements outlining impact on the victim
- Three Tier System: An element of juvenile justice providing maximum opportunity for rehabilitation
- Children's Court: A specialised lower court which deals with all matters of juvenile justice.
